ARTIST AGREEMENT & SUBMISSION CONTRACT

1. Eligibility and Submission

- The Artist confirms they are eligible to submit the Artwork as per the submission guidelines provided by the Organizer.
- The Artwork submitted must be original, created by the Artist, and must adhere to the size specification of 12 x 12 inches, 1.5" depth and ready to hang.
- The Artist agrees that their submission follows all rules and guidelines as outlined by the Organizer.

2. Ownership of Artwork

- CAUSE WE CAN retains full ownership of the Artwork submitted in lieu of admission fees.
- By submitting, the Artist grants the Organizer non-exclusive rights to use images of the Artwork for promotional, marketing, and exhibition purposes, both online and offline.

3. Juried Selection

- The Artist understands that the submission is subject to a juried process and that the Organizer makes no guarantee of acceptance into the exhibition.
- Decisions of the jury are final and not subject to appeal.

4. Exhibition and Display

- If selected, the Organizer will display the Artwork during the CAUSE WE CAN Bruce Grey art exhibition.
- The Organizer reserves the right to decide on the placement and arrangement of the Artwork for the exhibition.
- The Artist agrees that the Artwork will be ready for display, including framing or mounting if required.

5. Artwork Safety and Insurance

- The Organizer will take reasonable care in handling and displaying the Artwork but is not responsible for loss, theft, damage, or destruction of the Artwork.
- The Artist is responsible for insuring their own Artwork, if desired.

6. Sale of Artwork

- In the event of a sale, the Organizer retains sale to further their fundraising efforts for future CALL for ART events.

7. Artist's Representation

- The Artist represents and warrants that the submitted Artwork is original, does not infringe upon any third-party rights, and is not subject to any dispute over ownership or intellectual property.

8. Indemnification

- The Artist agrees to indemnify and hold harmless the Organizer, its employees, volunteers, and agents from any and all claims, damages, liabilities, and expenses arising out of the display, sale, or publication of the submitted Artwork.

9. Governing Law

- This Agreement shall be governed by and interpreted in accordance with the laws of the Province of Ontario.

10. Acceptance of Terms

- By signing below, the Artist acknowledges that they have read, understood, and agreed to all terms and conditions outlined in this Agreement.
